1. INTRODUCTION

Committed to sustain the passion of Indian spices and betterment of farmers, FSTL strives to lend a helping hand to the small and marginal spice growers, collectives, and developmental ventures to bring the economic and social inclusion.

With the aim of promoting sustainability at all levels of business, FSTL attempts to streamline the efforts of people working at grassroots with market forces. FSTL procures quality spices from the farmers directly, providing them a trade channel to promote their products in the market with better earnings. It supports the small-scale value-added spice brands in promoting their products through an opportunity for co-branding under the 'Flavourit' brand. The idea is to help them grow through sustainable cooperation.

The doctrine of FSTL is to project the long and continuing Indian tradition of spices; its deep and strong interactions in socio-economic and cultural realms. It functions as platform to hoist the various requirements of all stakeholders in the spices sector. FSTL is also committed to health and wellness of people and planet. It ensures natural taste and aroma of the spices, packaged in eco-friendly ways, suitable for modern lifestyle.

2. NOTICE INVITING EXPRESSION OF INTEREST (EOI) FOR EMPANELMENT OF VENDORS/SUPPLIERS

Flavourit Spices Trading Limited (FSTL) invites EOI from reputed Vendors/Suppliers of Spices, Spice Products and Others, with at least three years of experience, for empanelment as Vendors/Suppliers to supply these items for sale through FSTL outlets across various locations. Vendors/Suppliers willing to supply any items listed in Annexure- I & II may apply as per this Notice. During the empanelment period, preference will be given to empanelled Vendors/Suppliers for procuring any similar items listed in Annexure-I & II.

The EOI document, including terms and conditions, is available on the FSTL website (www.flavourit.com) and the Spices Board website (www.indianspices.com). Submit EOI in a sealed cover addressed to Dr Anilkumar K A, The Director, Flavourit Spices Trading Limited (FSTL), Sugandha Bhavan, Palarivattom P.O., Kochi – 682 025, either by Registered Post/Speed Post or in person as physical (offline) documents.

2.2 INSTRUCTIONS TO APPLICANTS FOR SUBMISSION OF EOI FOR EMPANELMENT OF VENDORS/SUPPLIERS FOR SUPPLY OF SPICES, SPICE PRODUCTS AND OTHERS.

(i) EOI Submission

The Technical Proposal for the EOI must be submitted in a sealed cover, accompanied by a forwarding letter that lists all enclosed documents. The envelope should be superscribed with: *“EOI for Empanelment of Vendors/Suppliers for Supply of Spices, Spice Products and Others for Flavourit Spices Trading Ltd”*. Applicants shall clearly indicate their full name and address on the sealed cover. Postal delays will not be accepted, and Technical proposal for EOI received after the specified time limit will be summarily rejected.

(ii) Application & Processing fee

No application & processing fee for participation for EOI

(iii) Earnest Money Deposit(EMD)

An EMD of ₹50,000/- (Rupees Fifty Thousand only) is mandatory. Remit to the same FSTL Account No. 7176002100002251, Punjab National Bank, Vennala Branch, IFSC: PUNB0717600, and attach proof with the Technical proposal for EOI. Technical proposal without proof of EMD payments will be summarily rejected.

EMD of unsuccessful applicants will be refunded within 30 days after finalization of the empanelment process. EMD will be refunded to the successful applicants within 30 days after submission of Performance Security. If a successful applicant fails to submit the performance security within the stipulated time, their EMD shall be forfeited.

EMD Exemptions (subject to valid documents):

- Micro and Small Enterprises (MSEs): Registered under the MSMED Act 2006, holding a valid Udyam Registration Certificate or NSIC certificate
- Startups: Recognized by the Department for Promotion of Industry and Internal Trade (DPIIT).
- Government Departments & PSUs: Central/State government ministries, departments, autonomous bodies under government and Public Sector Undertakings.

(iv) Performance Security (PBG)

Successful applicants fulfilling all the terms and conditions of the EOI shall be notified as List of Empanelled Vendors / Suppliers for Flavourit Spices Trading Limited (FSTL). Successful applicants must deposit ₹3,00,000/- (Rupees Three Lakhs only) as Performance Security within 15 days of notification in the form of an unconditional bank guarantee. This is non-refundable during active empanelment but refundable after the Empanelment period. The Bank Guarantee must be issued by any commercial bank in a format acceptable to FSTL and valid for 3 years (initial empanelment period).

Empanelled Vendors/Suppliers must renew the Performance Bank Guarantee (PBG) upon empanelment renewal or as required. FSTL reserves the right to invoke the PBG if the supplier fails to meet quality standards, resulting in FSTL's liability to any law enforcement agency or government authority.

3. GENERAL TERMS AND CONDITIONS

- 3.1 Vendors/Suppliers must comply with all applicable rules, regulations, and conditions for transacting with Flavourit Spices Trading Limited (FSTL). They shall be technically capable and financially sound to deliver the required Spices, Spice Products and Others.
- 3.2 Vendors/Suppliers must comply with FSSAI / HACCP/ Organic certification, etc and Attach copy of self-attested with seal of the firm document.
- 3.2 The Vendors/Suppliers with whom government transactions have been banned or suspended due to any reason including corrupt and fraudulent practices adopted by them will not be eligible to receive government contract.
- 3.3 The Empanelled Vendors/ suppliers will be prima facie be eligible for consideration for procurement of goods/items through Limited Tender Enquiry keeping in view of their credentials i.e. manufacturing capability, quality control systems, past performance (for the goods in question), financial background etc.
- 3.4 Firm, against whom punitive action has been taken by FSTL / government departments/ autonomous bodies under government / Public Sector Undertakings shall not be eligible for empanelment.

- 3.5 The different categories of empanelment of goods/items with required quality /standards will be as per **Annexure- I & II** of this EOI Document.
- 3.6 The Director, Flavourit Spices Trading Limited (FSTL) shall be the Competent Authority to deal with the applications and grant of empanelment on the basis of the recommendations of the Technical and Financial Committees of the FSTL.
- 3.7 FSTL is a separate legal entity under the Spices Board India. The Spices Board India shall not be held legally or financially liable for any acts, omissions, obligations, debts, or liabilities of FSTL, including but not limited to those arising from this EOI process, contract execution, or any related activities.
- 3.8 FSTL operates as a separate legal entity, and all obligations, liabilities, and disputes under this EOI shall be exclusively between FSTL and the vendor. Vendors agree to indemnify and hold harmless Spices Board India from any claims, demands, or proceedings related to this EOI or empanelment.

4. GENERAL INSTRUCTIONS

- 4.1 The technical proposal for EOI shall be complete in all respects and accompanied with all prescribed documents, shall be submitted on or before the due date and time of EOI. Empanelment shall be granted to the firms who fulfil all the specified requirements. Notification regarding Empanelled Vendors/ Suppliers for particular category/categories shall be published in FSTL website / Spices Board website with the approval of Competent Authority.
- 4.2 In case of violation of the terms and conditions of the empanelment, the status of empanelment of the firm will be cancelled immediately.
- 4.3 A registered firm will be liable to be removed from the list of Empanelled suppliers/vendors, when: -
- (a) It fails to abide by the terms and conditions under which the empanelment has been given.
 - (b) Makes any false declaration to Flavourit Spices Trading Limited (FSTL).
 - (c) Supplies goods of inferior quality or uninspected goods.
 - (d) Renders supply of inferior quality than the contracted ones.
 - (e) Fails to execute a contract or fails to execute it satisfactorily.
 - (f) Firm changes its production line affecting its performance adversely.
 - (g) The firm is declared bankrupt or insolvent.
 - (h) Fails to submit the required documents/information for review of empanelment, whenever required.
 - (i) Adopts unethical business practices, not acceptable to Flavourit Spices Trading Limited (FSTL) and

- (j) Any other ground which, in the opinion of the registering authority, is not in public interest.
- 4.4 The applicant should be a Manufacturer/Distributor/Supplier/Agent of the Brand under the particular Category that he/she/they are applying for. Distributors/Suppliers/Agents of the Brand under the particular Category will have to provide a valid Authorization Certificate from the Original Manufacturer (OM) of that Brand in that Category.
- 4.5 The firm will be considered for empanelment for an initial period of 3 years only, or till the time they remain an authorized supplier/vendor/dealer of the items in question as per the manufacturer's authorization certificate, whichever is earlier. Any change in authorized supplier/vendor/dealer of the items in question during the empanelment period must be notified to Flavourit Spices Trading Limited (FSTL) immediately. Empanelment of firms will be considered for renewal on the same terms and conditions as per requirement for further one more year subject to satisfactory performance of the firm during the initial period.
- 4.6 The empanelment period will be extended for a maximum period of 5 years. However, review will be done every year for evaluation of already registered Vendors/Suppliers. A notice in this regard shall be published on the websites of Flavourit Spices Trading Limited (FSTL) at the end of each year. The year, for this purpose, will commence with effect from the date of publication of List of Empanelled Vendors / Suppliers on the website of FSTL after completion of all necessary formalities/procedures. The name of the supplier whose performance is not satisfactory shall be deleted.
- 4.7 Average Annual Turnover: Minimum Rs. 20 lakhs during the last 3 Financial Years (FY 2022-23, 2023-24, 2024-25).
- 4.8 The concerned firm/company whose product has been declared as of spurious or adulterated quality and any criminal case is filed and is pending in any court shall not be eligible to participate in the EOI process. Convicted firms/company shall also not be eligible to participate in the EOI process. Similarly, firms/companies that have been blacklisted/banned/debarred by any central/state govt. or its organization or autonomous bodies are not eligible to participate in the EOI.
- 4.9 Any change of authorized Dealership/Distributorship should be intimated to the Director, Flavourit Spices Trading Ltd (FSTL) immediately on authorization of a new party or deletion of an existing party.
- 4.10 The Director, Flavourit Spices Trading Ltd (FSTL) reserves the rights to accept, consider or reject any or all applications without assigning any reasons thereof. The decision of the Director (FSTL), in respect of Empanelment of vendors /Suppliers under various categories of item shall be final and binding on all applicants.
- 4.11 Vendors/Suppliers once empanelled, shall have to promptly reply to all the enquiries, execute orders as per the order terms of Flavourit Spices Trading Ltd (FSTL) and keep the FSTL informed of new products/developments/innovative ideas that shall help in reducing the cost and improve quality, reliability etc.

- 4.12 This document is treated as a valid contract between FSTL and Vendor, and adherence to all aspects of fair-trade practices in executing the purchase orders placed by Flavourit Spices Trading Ltd (FSTL) from time to time during the empanelment period.
- 4.13 In the event an empanelled vendor breaches any terms and conditions of the FSTL supply order at any stage during the empanelment period, FSTL shall initiate legal action as per applicable rules and laws against the vendor, invoke the EMD/Performance Security, and debar/blacklist the vendor from further dealings with FSTL for a minimum period of three (3) years. The vendor shall not assign, sublet, or transfer the empanelment or any part thereof to any other party in any form. Any such assignment or subletting shall result in immediate termination of the empanelment without further notice.
- 4.14 All registered firms are expected to maintain absolute integrity, follow a high standard of business ethics and do-nothing unbecoming of a registered supplier.
- 4.15 The Director, Flavourit Spices Trading Ltd (FSTL) has all the rights to add/delete/alter any of the goods/items and to add/delete/amend any of the terms and conditions.
- 4.16 The Director, Flavourit Spices Trading Ltd (FSTL) has all the powers to blacklist a firm after following the procedures of principles of natural justice.
- 4.17 The Original Manufacturers (OMs) applying for Empanelment shall furnish the name and address of their Local Authorized Distributors / Dealers so that the copies of Purchase Orders (POs) can be endorsed to them for expeditious supply of goods/items. In such cases, proper Authorization Certificate as per **Annexure- IV** shall be submitted with the EOI/Quotation.
- 4.18 The applicant must possess a minimum of 3 years' experience in supplying similar items to Government offices/ PSUs/ Autonomous Bodies/ reputed organizations/ corporates/ or companies, as on the date of publication of the EOI. Necessary supporting documents like copy of purchase orders, performance evaluation certificate, payment certificate etc. for last three years to this effect must be submitted along with the offer.
- 4.19 At any time prior to date of submission of technical proposal, EOI Inviting Authority may, for any reason or decision, modify the terms & conditions of the EOI document by a Corrigendum to be displayed on the Website of FSTL and Spices Board. In order to provide reasonable time to take the amendment into account in preparing their technical proposals, EOI Inviting Authority may or may not, at his discretion, extend the date and time for submission of EOI.
- 4.20 Individual signing the technical proposal or other documents connected with empanelment must specify whether he/she is signing as: -
- (a) A sole proprietor of the concerned firm/agency or constituted attorney of such sole proprietor;

(b) A partner of the firm/agency, if it is a partnership firm, in such case he/she must have an Authority to sign the technical proposal for EOI documents and execute an agreement on behalf of the vendor /supplier and to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firm/agency.

(c) Director or a principal officer duly authorized by the Board of Directors of the Company, if it is a company.

(d) The applicant should sign and affix his/her firm's/agency's seal on each page of the technical proposal for EOI and all its annexures as a token acceptance of the terms and conditions of the EOI. No page should be removed /detached from this Notice Inviting EOI.

- 4.21 The applicant is at liberty either himself/herself or authorize not more than one representative to be present at the date and time of opening of the EOI. The representative attending the opening of the EOI on behalf of the EOI applicant should bring with him/her a Letter of Authority from the EOI applicant and proof of identification.

5. CONSOLIDATED ELIGIBILITY CRITERIA

- Minimum 3 years of experience (as on EOI publication date) in supplying similar items (spices/spice products) to Govt. offices/ PSUs /Autonomous Bodies/Reputed organizations/ corporates/ companies.
- Must be a Manufacturer, Distributor, Supplier, or Agent of the brand/category applying for.
- Distributors/Suppliers/Agents: Must hold valid Manufacturer's Authorization Certificate (Format: Annexure-IV).
- Products must comply with quality standards as per Annexure-I & II (FSSAI, HACCP, Organic certification, etc., where applicable).
- Average Annual Turnover: Minimum Rs. 20 lakhs during the last 3 Financial Years (FY 2022-23, 2023-24, 2024-25).
- EMD: Rs. 50,000/- (non-refundable for unsuccessful applicants; exemptions for MSEs/Udyam-registered, NSIC, Startups/DPIIT-recognized, Govt. Depts/PSUs with valid proof).
- The Applicant shall not be black listed, debarred, or banned by any Central/State Government, its organizations, or autonomous bodies; has no ongoing/pending criminal cases or convictions related to spurious/adulterated products; has no bankruptcy/insolvency declarations; has faced no punitive action (e.g., for corrupt/fraudulent practices) in the last 2 years (or as prescribed); and has no common stakeholders with blacklisted firms.
- All documents required to prove eligibility criteria must be submitted along with the Technical Proposal, as specified in Annexure III.

6. PROCEDURE FOR EMPANELMENT OF VENDORS / SUPPLIERS.

- 6.1 The applicant should clearly read all the pages of the EOI Document and furnish correct /relevant information / data.

- 6.2 The applicant should make sure before applying for empanelment under a particular category that he/she/they fulfil the required eligibility criteria & experience for that category of goods/ items.
- 6.3 Suppliers shall have to submit the EOI documents along with Annexures and all other required documents. The EMD should be submitted as stipulated in 2.2 (ii) & (iii) above. NOTE: The Applicant will need to mention items under each Category, for which they are applying for.
- 6.4 Incomplete applications in any respect, viz non-submission of any required document, information, EMD etc. will be rejected. However, the Director, Flavourit Spices Trading Ltd (FSTL) reserves the right to obtain any document from the suppliers/vendors as deemed necessary for their empanelment before granting empanelment of such supplier/vendor.
- 6.5 Vendors/Suppliers registered with NSIC/MSME/Startups should submit their valid Registration Certificate along with other certified documents.
- 6.6 Any conditional EOI shall be rejected summarily.

7. SUBMISSION OF APPLICATION FOR EMPANELMENT

When the Flavourit Spices Trading Ltd (FSTL) invites applications for empanelment of vendors/ suppliers for supply of Spices, Spice Products and Others, any supplier fulfilling the 'general criteria and requirements as laid down by the FSTL from time to time may apply for empanelment in the prescribed application form (Annexure III) along with the requisite documents and EMD.

The following documents, duly authenticated, shall be submitted along with the application form:

- a) Legal Identity of the Supplier: (any one or more of the following documents)
- (i) Certificate of Registration by Company Registrar and Memorandum of Articles in case the firm is a Limited Company.
 - (ii) Partnership Deed in case the firm is a Partnership entity.
 - (iii) Certificate from Chartered Accountant establishing the proprietorship or Affidavit on Non-Judicial Stamp Paper of Rs.200/- by Proprietor that he is the sole Proprietor, duly attested by a Notary Public in case of the firm being a proprietorship business entity.
 - (iv) Certificate of Registration under the Goods & Service Tax Act.
 - (v) IT Returns for last three years (for Annual Turn over)
 - (vi) Copy of purchase orders issued by the purchasing authority.

The application form, duly filled in, shall be signed by its owner/top management, i.e., Proprietor, Partner, Director, Chief Executive Officer (CEO) or Head, as the case may be, or any other person so authorized for the purpose by the Management. The name and designation of the person signing the application shall be recorded legibly in the space for the purpose of the application form. In case the application is signed by an authorized signatory, a certificate from the top management of the laboratory, on its official letterhead, bearing the seal of the laboratory and clearly attesting to the signature of the authorized signatory, shall also be required to be submitted with the application.

The application form in the prescribed format (Annexure- III) along with the required documents and the covering check-list by post/courier, shall be submitted to the FSTL, in the following address:

The envelope containing the application along with accompanying documents, as above, shall be superscribed with '*EOI for Empanelment of Vendors/Suppliers for Supply of Spices, Spice Products and Others for Flavourit Spices Trading Ltd*'. .

8. PROCESS OF EMPANELMENT

Verification of the application: A Verification Committee (VC) constituted by the FSTL for the purpose will verify the application and other submitted documents. If required, the committee shall call for further clarifications and documents from the Vendors/Suppliers. Based on verification of application, certificate, closure of all non-conformities observed, if any, and confirmation on record that criteria for empanelment are met, the application along with the report of verification will be forwarded to the 'Empanelment Committee' (EC) for further necessary actions.

The Empanelment Committee (EC) constituted for the purpose will examine the report of the VC. The EC may accept, reject, or return the application to the VC for further clarification. The Director, FSTL or the officer authorized by the Director for the purpose will be the authorized person to issue the formal communication to the empaneled firms.

9. TERMS & CONDITIONS AFTER EMPANELMENT

The empanelment shall be for 3 years and the empaneled firms have to enter into the MOU with FSTL. The shortlisted firms shall submit the Performance Bank Guarantee (PBG) within 15 days of receipt of communication, and only upon receipt of the PBG will they be considered for empanelment.

Payment clause.

As per the requirement, FSTL will invite quotations from empanelled Vendors/Suppliers of a particular category/item. While submitting quotations, the suppliers/vendors are required to mention tax rate applicable on each category/item, otherwise rates will be treated as inclusive of all taxes. Purchase Order (PO) will be issued to the L1 supplier and payment will be released after delivery of items and against submission of tax invoice subject to inspection and acceptance of the item by FSTL.

10. PROCEDURE OF PROCUREMENT FROM EMPANELMENT FROM SUPPLIERS

During the empanelment period, FSTL shall procure spices, spice products, and other similar items listed in Annexure-I & II exclusively from empanelled vendors/suppliers as per the following standardized procedure:

Quotation Invitation

- FSTL will invite sealed quotations from all empanelled vendors/suppliers through email, portal, or uploaded notice whenever a procurement requirement arises.
- Quotations along with product samples must be submitted in **sealed envelopes** (physical submission) by the specified deadline.
- Quotations shall remain valid for [45 days or period specified in the quotation notice] from the due date of submission.
- Late quotations or those without samples shall be summarily rejected.
-

Additional Quantity Provision

- FSTL reserves the right to procure additional quantity up to 25% of the ordered items at the same quoted rates, terms, and conditions during the validity period mentioned in the quotation invited.
- If mutually agreeable, FSTL may extend procurement of additional quantity for up to 15 days beyond the original quotation validity without price escalation or change in terms.
- The empanelled vendor/supplier shall be obligated to fulfill such additional requirements.

Award Criteria

- Work order shall be awarded to the L-1 vendor/supplier (lowest quoted price) whose offer is substantially responsive and whose sample meets all technical/quality specifications.
- Tie-breaker criteria: Preference to vendor with superior past performance, delivery record, or earlier empanelment date.
- FSTL reserves the right to split orders among multiple L-1 vendors for risk distribution, urgency, or operational needs.

Delivery Timeline and Quality Compliance

- Selected vendor/supplier shall supply/deliver items strictly within the timeframe stipulated in the work order.
- Supplies must exactly match the approved sample, specifications, quality standards, and packaging requirements specified in the work order.
- FSTL reserves the right to inspect/test supplies/ quality tests at delivery point or later; non-conforming goods shall be rejected.

Consequences of Non-Compliance

Failure to supply within the stipulated time, supply of sub-standard or defective goods, or deviation from the approved sample shall attract any, a combination, or all of the following penalties, without prejudice to other legal remedies:

- Immediate cancellation of work order.
- Forfeiture of full EMD/Performance Security.
- Disqualification from current and all future procurements under this empanelment.
- Blacklisting/debarment from FSTL dealings for minimum three (3) years.
- Recovery of losses/damages/penalties from vendor through legal means, including adjustment against any pending dues.

Additional Safeguards

- FSTL decision on sample quality, L-1 status (considering the quality of the sample received), and non-compliance shall be final and binding.
- Vendors must maintain traceability records for supplied batches for [12 months] post-delivery.
- Force Majeure clause applicable only with prior FSTL approval and documented proof.

11. GENERAL

The empanelment is non-transferable and any situation not covered under this Scheme, will be considered by the FSTL and the decision of the FSTL shall be final.

12. JURISDICTION

All the legal disputes regarding the Empanelment of vendors/ suppliers for the supply of Spices, Spice Products and Others will be under the jurisdiction of Hon. High Court of Kerala, Cochin.
